## **Price announcement for Fairtrade Coffee**

Dear Fairtrade partners,

We are pleased to announce the new Fairtrade Coffee Prices. The decisions on the new price values were taken by the Standards Committee in its 107 meeting on 24 March 2023. The new prices are the result of a project which began in Q2 2022, with a public consultation, gathering inputs from more than 500 stakeholders, representing Fairtrade certified coffee SPOs and Fairtrade certified coffee traders, as well as Fairtrade member organizations. We would like to take the opportunity to thank again all those who contributed during the project.

The changes include revised Fairtrade minimum prices for Arabica and Robusta coffee as well as an Organic Differential value. For details on the decisions please refer to the minutes of the Standards Committee meeting, available soon on our website, here.

The new Fairtrade Prices are presented in the table above. The Fairtrade Premium is paid in addition

to the Fairtrade Minimum Price or market price, whichever is higher. Fairtrade organic differential is

calculated by adding this extra value on top of the Fairtrade minimum price for conventional coffee or

market reference price, whichever is higher. The Fairtrade Prices are also available on our website

Please note, for all types of contracts (including fixed price contracts and price-to-be-fixed contracts)

signed on or after 1 August 2023, the new Fairtrade prices must be respected. For price-to-be-fixed

contracts signed before 1 August 2023 but where the price fixation date is on or after 1 August 2023,

the previous Fairtrade prices are considered to be in effect.
