

# Project Assignment Seed Cotton Price Review (Version 08.08.2024)

### **Rationale for and justification of need for the project:**

The current Fairtrade Minimum Prices (FMP) for seed cotton were last reviewed in 2011. The world market prices for seed cotton have risen during the past years, resulting from a series of environmental and political events, long-term effects of the Covid-19 pandemic and worldwide inflation. Considering these reasons, the Fairtrade Minimum Prices for seed cotton are now due for review.

Thus, Fairtrade International reviewed its Cost of Sustainable Production (COSP) guidance document in 2023 where the methodological approach, data collection procedures and calculation of costs of production for all Fairtrade products were revised. The new COSP template will be reviewed to fit the specific needs of seed cotton production.

The price review will therefore include new cost items referring to standard changes that have incurred in the meantime, such as risen compliance costs with the standards, environmental and Human Rights and Environmental Due Diligence (HREDD) related costs.

### **Risk assessment:**

- Limitations to collect COSP from all seed cotton producing regions *Mitigation plan:* Concentrate on regions most relevant for the trade of the last years and certified producers, combine regions where possible
- Lack of expertise and support in the field on cotton *Mitigation plan*: Operational work will be supported by NFOs and their field staff, a consultant experienced with cotton production and trading will be hired for supporting the project team

# **Project Goal and Objectives**

## Goal:

To review the existing seed cotton price model and prices values.

# **Objectives:**

- 1. Evaluate if the current pricing model is fit for purpose
- With the intention to increase Fairtrade sales, farmers' incomes and commercial partners' willingness to pay.
- To incorporate HREDD and other environmental costs.
- To identify the biggest seed cotton producing regions and future trends
- To asses weather a global, country specific or regional FMP is the best solution
- To identify how to deal with local prices set by governments (e.g. India and Pakistan)
- To review the Fairtrade Premium of Seed cotton: Including the decision between a fixed Fairtrade Premium or percentage and new definition of the Premium value

#### 2. Revision of COSP template

 To define Fairtrade standard compliance cost items and include them in the COSP template. This work involves the identification and inclusion of HREDD and other environmental costs applicable to seed cotton, following the COSP guidelines and generic COSP template approved by the SC in March 2023.

#### 3. Collect COSP data

- Based on the established pricing model and COSP template, COSP data will be collected from seed cotton producers in the identified regions of importance
- Producer networks will be trained to collect the COSP data
- Producer networks will host workshops to collect the COSP data

#### 4. Update the model (if necessary) and the values

- Based on the proposed Pricing model and COSP data, proposals for the FMP and FP will be calculated.
- The proposal will be discussed with the project team and undergo a consultation process
- The final proposal will be presented to the Standards Committee for decision.

### **NEW:** Connection with Theory of Change (ToC):

This project relates to the first goal of Fairtrade International, which is to constantly pursuit ways to make trade fairer. Specifically this projects supports this through providing a Fairtrade Minimum Price as a safety net that covers the cost of sustainable production of producers, in line with compliance costs with the Fairtrade standards and establishment of a Fairtrade Premium.
